#### Lemonaid Credit Hire / Lemonaid Credit Repair Route

Lemonaid will appoint one of their chosen partners who will deal with the vehicle repairs and provide you with a courtesy vehicle if it is required.

You will not have to pay an excess once your vehicle is repaired. The credit hire company will re-coup the costs of the hire and/or repair directly from the third party insurer.

OR

#### Comprehensive Route

If the accident has left you without a vehicle, Lemonaid may be able to offer you a courtesy vehicle which the third party insurer will pay for.

Lemonaid will arrange for your insurer to deal with your vehicle repairs. You will pay your excess to the repair garage when you collect your vehicle.

On your behalf Lemonaid claims will recover the excess you have paid from the third party insurer.

OR

#### Third Party Insurer Route

If the accident has left you without a vehicle, Lemonaid may be able to offer you a courtesy vehicle which the third party insurer will pay for.

The third party insurer will deal with the repairs to your vehicle and you will not be charged your policy excess. The speed that your claim is handled will depend on the third party insurer's service levels.

Note: The third party insurer may offer their own approved repairer or you may elect to use your preferred repairer in both instances you might have to wait for a repair estimate to be approved.

You can decide which one of the following **2 ways** you wish for Lemonaid to deal with your claim

#### Lemonaid Credit Hire / Lemonaid Credit Repair Route

Lemonaid will appoint one of their chosen partners who will deal with the vehicle repairs and provide you with a courtesy vehicle if it is required.

You obtain a repair estimate and send it to Lemonaid

**Use a repairer provided by Lemonaid Claims**

Lemonaid's repairer will make contact with you to arrange an estimate

**Use one of your insurer's authorised repairers**

Your insurer will make contact with you to arrange an estimate

Your insurer will instruct their engineers to authorise the repairs or to carry out a vehicle inspection

Estimate is sent to your insurer by Lemonaid

**If your vehicle is repairable**

The works are carried out and you pay your policy excess to the repairer on completion

**If your vehicle is written off**

Your insurers will offer you a claim settlement sum which you have the right to question if you feel it is too low

Lemonaid will make contact with you to ensure the repairs carried out were satisfactory or that you have received your claim settlement from your insurer.

If you have purchased an **excess protection** policy from us, please make Lemonaid aware and they will assist you in making a claim for the excess sum you have already paid.
